This document sets out the top five execution venues (hereafter “Top 5 Venues Report”) where Millennium Banque Privée (hereafter referred as “MBP”) executed client orders in the preceding year in relation to dealings in financial instruments, as required by the Markets in Financial Instruments Directive (“MIFID II”) 2014/65/EU.

This Top 5 Venues Report is linked to the principles defined in the Order Execution Policy of MBP (hereafter “Order Execution Policy”; available on the MBP website) and is intended to cover the period from January 1st, 2019 to December 31st, 2019.

Millennium Banque Privée is a Bank with its registered office in Switzerland, authorised and supervised by the Swiss Financial Market Supervisory Authority FINMA. Since Switzerland is not a member of the European Economic Area, MiFID II does not apply directly to MBP. Nevertheless, MBP will apply the standards that are stipulated by MiFID II but this Report may not include some of the detail required by RTS 28.
